# YOUR CONTRACT & LOAN ARE DONE WHAT'S NEXT?

## DISNEY WAIVES RIGHT TO BUY

### DVC HAS 30 DAYS BY LAW TO WAIVE OR BUY

WHEN DISNEY WAIVES THEIR RIGHT, THE TITLE COMPANY WILL NOTIFY YOUR AGENT AND US AS YOUR LENDER. WE WILL THEN FORWARD YOUR LOAN DOCUMENTS DIRECTLY TO THE TITLE COMPANY WHO WILL CREATE ONE CLOSING PACKAGE AND SEND OUT.

## SIGN ALL DOCUMENTS

### SIGN, DATE, AND HAVE DOCUMENTS NOTARIZED

WHEN YOU RECEIVE YOUR CLOSING PACKAGE A FEW DOCUMENTS WILL NEED TO BE NOTARIZED TOO. THEN RETURN ALL ORIGINAL DOCUMENTS TO THE TITLE COMPANY WITH ANY FUNDS REMAINING EXCLUDING THE LOAN AMOUNT WHICH WE WILL PROVIDE. PLEASE SEND EVERYTHING PROMPTLY TO ENSURE A TIMELY CLOSING.

## CLOSING

### ONCE ALL DOCUMENTS ARE RECEIVED BY TITLE

VACATION CLUB LOANS WILL SEND A WIRE IMMEDIATELY TO YOUR TITLE COMPANY FOR THE LOAN AND TITLE WILL RECORD YOUR NEW DEED. THE RECORDED DEED IS THEN FORWARDED TO DISNEY TO CREATE (OR ADD ON TO) YOUR DVC MEMBERSHIP.

## ACCESS TO DVC POINTS

### DVC WILL RECEIVE YOUR DEED AND SET UP ACCOUNT

DISNEY TAKES APPROXIMATELY 21 DAYS TO SET UP YOUR ONLINE ACCOUNT AND SEND YOU A "WELCOME HOME" LETTER IN THE MAIL. YOU CAN NOW USE YOUR POINTS TO BOOK!
